**P. Licensing Objectives**

General

Staff training shall be recorded and updated every 6 months  
Training shall cover the requirements for ID as part of age verification, and other relevant matters relating to the licensing objectives, and the responsibilities of staff  
The licence holder shall ensure that a refusals register is kept on the premises and that this shall be immediately available upon request of an authorised officer. The register shall record any refused sale OF ALCOHOL. The refusal register shall be inspected on a regular basis (at least weekly) by the DPS and signed by the DPS that they have checked the register  
At least 12 months of refusal register details shall be retained and made available upon request by an authorised officer

The premises licence holder shall ensure that a 2 challenge 25 policy is adopted on the premises at all times. Signage of the 2 challenge 25 policy shall be prominently displayed on the premises.

Acceptable identification accepted by the premises licence holder, DPS, or other staff members shall be a passport, photo driving licence or PASS accredited identity card  
Signage shall be displayed in a prominent position on the premises requesting that customers leave quietly  
Signage shall be prominently displayed warning customers of the legal penalties for purchasing alcohol for any person under the age of 18 years
