am employed by the London Borough of Brent as a Licensing Officer. My duties include enforcing the Licensing Act 2003 and ensuring that licence holders are compliant. On Thursday 9 th June 2016 I received a complaint email via James Richards who is the Antisocial Behaviour Officer for the Kilburn area. He had been contacted by who is a at the MP Moran & Sons Builders and Plumbing Merchants at 293-301 Kilburn High Road London NW6 7JR. This builders merchants is located on the other side of Drakes Court Yard, London NW6 7JR which is a service road between their premises and The Good Ship. A land registry search of Drakes Court was carried out and it transpires that the service road is owned by MP Moran. The complainant stated that, during the evenings when the Good Ship is open, the service road is used for all types of antisocial activities. It has been alledged by MP Moran that's in the past they have had issues with customers from The Good Ship urinating and vomiting in Drakes Court Yard. Stated in her email to The Community Safety Team on 7 th June 2016 that in the early hours of Sunday 5 th June 2016 a group of people came out of the Good Ship Pub at around 4am and begain loitering in the service road at Drakes Court. A male was attacked which was caught on the CCTV from MP Moran that is facing down the service road. The provided James and I with the CCTV footage which I collected on Monday 13 th June 2016. I also requested CCTV from the Good Ship from the weekend of 4 th and 5 th June 2016 this was also collected on Monday 13 th June 2016. On Friday 1 st July 2016 Jame and I watched the CCTV from both MP Moran and The Good Ship. The CCTV showed the following: Sunday 5 th June 2016 - early hours of Sunday morning at 04:33hrs an assault took place on a male in Drakes Court Yard. The male appeared to be white in his early 20s, however this is unclear due to the quality of the night time vision of the CCTV. This male was attacked by a black male sporting a very large afro, dark bottoms and a white sh
