BARHAM PARK UNIT 1 CARD ROOM, 660 HARROW ROAD, WEMBLEY RECOMMENDATION

That the Trust note the details below and approve the lease of Unit 1 The Card Room to Tamu Samaj UK (TSUK) for a 7 year term.

Details

The Trust agreed on the 7 July 2015 that the Card Room be marketed under Brent Council's Community Asset Transfer (CAT) policy. Tamu Samaj UK (TSUK) and the Shree Vishwakarama Association (SVAUK) presented their proposals on 26th January 2017.

The attached table is in alignment to the criteria set out in the Council's CAT policy. Each bidder has a description of how it meets the criteria.

Officers considered that the 2 parties were very close in terms of their overall approach and fit with the CAT policy. TSUK propose a use that is wider in terms of impacts on a wider range of the community and positive impact on the park and a higher social value measure. SVAUK presented a stronger financial proposal.

The Trust needs to therefore weigh up the relative benefits of which of the 2 bidders it would like to approve.

Friends of Barham Library although submitting a proposal, required a longer lease than the 7 years offered. Therefore whilst the Trust have other offers that meet the criteria this bidder did not go to the presentation round.

SAAFI (Refugee outreach) did not submit any information about the Social Value Test and this is a key element of the CAT and therefore this bidder did not go the presentation round.
